# Sub: Intimation of Scheme of Amalgamation under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015

In terms of Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulations"), we wish to inform that the Board of Directors of the Company, at its meeting held today i.e. November 14, 2022, inter-alia, considered and approved the Scheme of Amalgamation of DME Infra Private Limited (the Transferor Company 1') and Welspun-Kaveri Infraprojects JV Private Limited ('the Transferor Company 2') and Welspun Infraconstruct Private Limited ('the Transferor Company 3') and Corbello Trading Private Limited ('the Transferor Company 4') and RGY Roads Private Limited ('the Transferor Company 5') with Welspun Enterprises Limited ('the Transferee Company') and their respective shareholders ('Scheme'), as may be modified from time to time pursuant to the provisions of Sections 230 to 232 and other applicable sections of the Companies Act, 2013 and other applicable provisions, if any, of the Companies Act, 2013, and subject to the requisite approvals and sanction of the jurisdictional bench of National Company Law Tribunal ('NCLT') and subject to the approval of shareholders and / or creditors of the Company, Central Government, or such other competent authority as may be directed by the NCLT.

The salient features of the proposed Scheme, inter alia are given as under:

- The proposed Appointed Date for the amalgamation will be as follows:
  - April 01, 2022, for amalgamation of DME Infra Private Limited and Welspun Infraconstruct Private Limited with the Company
  - May 06, 2022, for amalgamation of Welspun-Kaveri Infraprojects JV Private Limited with the Company
  - September 05, 2022, for amalgamation of Corbello Trading Private Limited with the Company
  - September 28, 2022, for amalgamation of RGY Roads Private Limited with the Company

- The entire assets and liabilities of DME Infra Private Limited, Welspun-Kaveri Infraprojects JV Private Limited, Welspun Infraconstruct Private Limited, Corbello Trading Private Limited and RGY Roads Private Limited (hereinafter collectively referred to as 'Transferor Companies') to be transferred to and vested by the Company.
- As on the date of approval of this Scheme, the entire share capital of the Transferor Companies is held by the Company. Upon the Scheme becoming effective, no equity shares of the Company shall be allotted in lieu or exchange of the holding of the Company in the Transferor Companies and accordingly, equity shares held by the Company in the Transferor Companies shall stand cancelled on the Effective Date (*as defined in the Scheme*) without any further act, instrument or deed.

The Scheme as approved by the Board of Directors will be available on the website of the Company at <u>www.welspunenterprises.com</u> post submitting the same to the stock exchanges.

In terms of the Listing Regulations read with SEBI Circular No. CIR/CFD/CMD/4/2015 dated 9 September, 2015, we are furnishing herewith the details of the Scheme as **Annexure - A**.
