Dear Sir/Madam,

Please note that requisite approvals from regulator have been obtained to acquire 100% stake in Chikhali-Tarsod Highways Private Limited ("CTHPL"). Accordingly for a total consideration of Rs. 8.34 crore, the Company through exercise of call option has acquired from Vishvaraj Environment Private Limited (co-venturer) balance 51% stake of Corbello Trading Private Limited ("Corbello"), the holding company of CTHPL, thereby becoming 100% owner of Corbello and in effect CTHPL.

It may be noted that CTHPL has achieved PCOD with effect from August 25, 2021 and subsequently also received first full annuity from National Highways Authority of India on April 23, 2022.

Brief financial details of Corbello are attached as Annexure A.
