Sub.: Receipt of early-completion Bonus by Welspun Delhi Meerut Expressway Private Limited in relation to the Delhi-Meerut Expressway Package-1.

Further to the disclosure dated June 12, 2019 with respect to the above mentioned subject, please read the date of completion of Delhi Meerut Expressway Package-1 project as "June 28, 2018" instead of "June 28, 2019". The other details in the disclosure remain unchanged.

The text of revised disclosure is as follows:

We are pleased to inform that Welspun Delhi Meerut Expressway Private Limited (a wholly-owned subsidiary of the Company) has received Rs. 27.09 crore (excluding GST) as Bonus from National Highways Authority of India (NHAI) for early completion of Delhi-Meerut Expressway Package-1 on June 28, 2018, 332 days ahead of the scheduled completion date.

The Delhi-Meerut Expressway Package-1 was the first Hybrid Annuity Model (HAM) project of NHAI to achieve both Financial Closure as well as Commercial Operation Date (COD). The first annuity for the project was received in January 2019 and the next annuity is expected by July 2019.


