The Design and Build Contract includes construction of a 8.48 km tunnel from Dharavi Wastewater

Treatment Facility (WWTF) to Ghatkopar WWTF (DGT Project)

Contract value of the project is Rs. 1989.40 Crores (excluding GST)

**National, 8**<sup>th</sup> **October, 2024** – Welspun Enterprises Limited (WEL), the infrastructure and energy arm of Welspun World, has secured a significant Design and Build contract for the design and construction of Tertiary Treated Water Conveyance Tunnel from Dharavi Wastewater Treatment Facility (WWTF) to Ghatkopar WWTF, from the Brihanmumbai Municipal Corporation (BMC).

The contract, valued at Rs. 1989.40 Crores (excluding GST), encompasses the design and construction of two very deep shafts at Ghatkopar WWTF and Dharavi WWTF, and an 8.48 km long reinforced insitu concrete lined tunnel of 2.7 metre finished diameter. This tunnel is to be constructed using tunnel boring machine (TBM). The project is to be completed within a timeframe of 93 months.
