<u>Sub: Disclosure under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements)</u> <u>Regulations, 2015 (SEBI Listing Regulations).</u>

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we wish to inform you that our wholly-owned subsidiary, ARSS Bus Terminal Private Limited ("ABTPL") had entered into a Concession Agreement ("the Agreement") with the Odisha State Road Transport Corporation ("OSRTC") for development of Baramunda Bus Terminal on a Public - Private Partnership Build-Operate-Transfer ("PPP-BOT") basis.

Pursuant to an order passed by the Hon'ble High Court, OSRTC terminated this Agreement. Following such termination, ABTPL raised claims for compensation towards costs incurred and losses suffered, which were denied by OSRTC. Consequently, the disputes were referred to arbitration.

The Arbitral Tribunal, by award dated November 30, 2021 in favour of ABTPL, awarded a sum ₹18.43 Crore to be paid within ninety days failing which interest @ 12% per annum was applicable.

Subsequently, OSRTC challenged the award before the Ld. Civil Judge (Senior Division), Commercial Court, Bhubaneswar. OSRTC also deposited ~₹ 11 Crore with the court.

On July 03, 2025, the Ld. Civil Judge (Senior Division), Commercial Court, Bhubaneswar, dismissed the challenge of OSRTC and upheld the arbitral award in favour of ABTPL. As on the date of the order, the aggregate amount (including interest) receivable by ABTPL from OSRTC is expected to be ~₹ 23 Crore.

ABTPL will initiate appropriate steps to enforce the award against OSRTC. OSRTC is entitled to appeal the order dated July 03, 2025.

We further wish to clarify that Welspun Enterprises Limited, the parent company, has already given effect of the original award amount in its books of accounts.

The formal communication of the Court's order was received by the Company post 20:00 hours on July 07, 2025.
